Introduction

This Memo to Users contains information for H215L and should be reviewed before beginning the installation process.

Secure BFX for z/OS (H215L) Release 1.3 is NOT compatible or interoperable with other **non-secure** BFX products on other platforms, as well as with previous releases of H211, unless a Secure TNP product is deployed to perform the bridging to the legacy products.

H215L is available by download.

New Features

This product is functionally equivalent to (non-secure) H211 Releases 1.6L and 1.7 with the added capability of optionally sending the jobfile (and the associated Secure BFX protocol) privately/securely. This product also has the capability of optionally sending the user data (and associated Secure BFX protocol) privately/securely.

This release supports configurations that include Secure TNPxx4 and legacy BFX and NetEx Requester combinations (i.e TNP804, H291 and H297). The Secure TNP bridges the legacy products to the Secure products.

Installation

Installation Notes

1. H215L is available as a downloadable distribution. Download instructions can be obtained by contacting support@netex.com.
2. H215L Release 1.3 is distributed as a downloadable package that includes a scripted batch job and sets of distribution libraries, all packaged together in TSO TRANSMIT format.
3. Follow the installation instructions in the *H215L Secure Bulk File Transfer (BFX) for IBM z/OS Operating Systems Software Reference Manual* to complete the installation.
4. Check if there are any H215L updates by going to www.netex.com, then clicking on the 'Support' tab, then navigating to 'Products', then selecting the 'IBM System z/OS (H21x)' link on the right side of the window, and then clicking on 'Updates' in the 'BFX [H215L]' entry for the appropriate version. If there are any, download them and follow their installation instructions.
5. The new version of H215L requires a larger region size than the H211 product. The minimum region size for H215L is 2 Megabytes. If a smaller region size is coded on the BFX jobstream, then the region size will need to be increased. If a region size is not coded, the default region size from the JES jobclass statement (region=) will take effect. Running BFX in a REGION=0M will require no more resources than running in a REGION=2M. This will prevent having to increase the region size in the future if additional virtual storage is required.

Release 1.0

This is a new product release which is functionally compatible to the non-secure H211L Release 1.6.

Known Problems

The installation default and the default in the INST file which pertain to setting JSEC to ON fails in Release 1.3. In order to run BFXJS with JSEC on, the parameter will need to be in the startup proc. Make changes similar to the following:

Change the lines that look like:

```
//BFXJS EXEC PGM=BFXJS,  
//          TIME=1440,  
//          PARM=''
```

To look like the following by commenting out the PARM statement and removing the comma after the TIME statement

```
//BFXJS EXEC PGM=BFXJS,  
//          TIME=1440  
//*          PARM=''
```

Then change the following lines:

```
//*SYSIN    DD  *  
//*  
***** Bottom of Data *****
```

To the following by uncomment the SYSIN DD * statement and add a line with the startup/default parameters you want BFXJS to use (the - is necessary). Change the next line from /** to /*

The lines should look something like this:

```
//SYSIN    DD  *  
          JSEC JSAUTH SNXERR SNXINF MSGLVL=0 -  
/*  
***** Bottom of Data*****
```
